## Tea for the Queen

By now you will have received the invitation for **Tea for the Queen** on Sunday 12th June 1pm - 3pm at Fairfield Village Hall; an indoor *Bring and Share* Lunch to celebrate the Queen's 90<sup>th</sup> birthday.

This celebratory event is open to residents, family & friends of Fairfield, Wildmoor & Stoneybridge, children that attend the First School and people that work in our community.

**Tea for the Queen** is free to enter and will include live entertainment, a children's **Fancy Dress** competition, an adults **Hat for the Queen** competition and a **Queen at 90** Quiz. Children will be asked to help design a birthday card that will be sent to HM the Queen.

Each family that attends will receive a commemorative book, *The Servant Queen*.



#### Donations required:

- Food for to be shared; e.g. a plate of sandwiches, cake or nibbles;
- Magazines containing images of the Queen and the Royal Family that can be cut out to create the birthday card;
- Raffles prizes there will be a raffle, money raised will help cover costs of putting on this event and the book that each family will receive; and

#### Rules:

- 1) Competition is open to residents that live in Fairfield & Stoneybridge;
- 2) To enter the competition make sure your floral displays can be seen and enjoyed by the 1st July;
- 2) Judging will take place during July;
- 2) Displays must be sited on resident's property and not on public paths and highway;
- 3) Floral displays must be seen and can be enjoyed by people passing by;
- 4) There will be four prizes, an overall winner (£20) and three 2nd place winners (£10 each);
- 5) Judges decision is final;
- 6) The rules can change without notice;
- 7) Even though this is a competition, it is a bit of fun.

## Parish Logo Competition - Win £100

The Parish Council has completed the process of formally changing its name to Belbroughton and Fairfield Parish Council. It would be appropriate to adopt a new logo for the council which better describes the parish to coincide with the change of name. The new logo will be used on the Council's stationery and publicity materials.

The Council would like to invite design ideas from all members of the community and it is hoped that a suitable design can be chosen from the entries.

The logo should be attractive, optimistic and forward looking while having strong references to the area. The design could include features of the local environment, its geography, people, history, buildings, activities etc. Designs should be submitted either on A4 paper, or digitally in the form of a JPEG scan/photo or in a Word file. It must be noted that the Parish Council will not be obliged to select a "winner" if it is judged that a suitable logo has not been submitted while the Council's decision will be final.

# Speeding & Parking Through Fairfield

At the request of the Fairfield Village Community Association (FVCA) traffic monitoring has been carried out by the County Council, results are being collated and will be analysed by the Community Association, West Mercia Police & the Safer Road Partnership.

Worcestershire County Council has acknowledged the issues the village faces and has detailed some of the constraints with regard solutions. FVCA are working with the County Council and other agencies to identify realistic, affordable and workable solutions that do not have a negative impact on our community.

Children from Fairfield First School's Eco-team who have identified a simple solution that may take a few cars off Stourbridge Road & they have written to the Parish Council suggestion parking lines on the Recreation Ground carpark. The school has also written to parents reminding that they can use the Swan carpark and to avoid parking along Stourbridge Road.

### Veolia

Some of you may not be aware of the Veolia Planning Application.

Veolia are planning to build an Incinerator Bottom Ash (IBA) Recycling Facility accepting 120,000 tonnes of IBA per annum. The site they have chosen, at Stoneybridge Island, is above the aquifer that supplies drinking water to 19,500 homes in the Bromsgrove area.

This planning application is being objected to by:
